Assumptions of politicians, teachers, and other professionals about integration often fall short of theoretical and empirical support. This work seeks to bridge this gap by proposing a new theoretical concept looking at personal security and testing it empirically with data from 21 European countries. As migration often affects migrants and members of the receiving society alike both have been included in the analysis. Whereas classic identity research strongly relies on qualitative techniques and experimental designs, Yvonne Hapke adopts a quantitative approach. She successfully demonstrates that ethnic closure and xenophobia are the result of damaged or threatened identities and pose a major obstacle to integration. However, welcoming individuals with all of their defining characteristics, needs, and identities helps people to develop trust in others as well as in political institutions and makes them more confident about their country's future.

Muslim Marriage in Western Courts Pascale

Fournier.2016-04-29 This book describes and analyses the notion of Mahr, the Muslim custom whereby the groom has to give a gift to the bride in consideration of the marriage. It explores how Western courts, specifically in Canada, the United States, France, and Germany, have approached and interpreted Mahr. Although the outcomes of the cases provide an illustrative framework for the book, the focus is broader than simply the adjudicative endeavours. The work explores the concept of liberalism, which purportedly champions individuals and individual choice concurrently with freedom and equality. Tensions between and

among these concepts, however, inevitably arise. The acknowledgment and exploration of these intertwined tensions forms an important underpinning for the book. Through the analysis of case law from these four countries, this study suggests that transplanting Mahr from Islamic law into a Western courtroom cannot be undone: it immediately becomes rooted in the countries' legal, historical, political, and social backgrounds and flourishes (or fails) in diverse and unexpected ways. Rather than being the concept described by classical Islamic jurists, Mahr is interpreted according to wildly varied legal constructs and concepts such as multiculturalism, fairness, public policy, and gender equality. Moreover, Islamic law travels with a multiplicity of voices, and it is this complex hybridity (a fragmented and disjointed Mahr) which will be mediated through Western law. Returning to the overarching concept of liberalism, the book proposes that distributive consequences rather than recognition occupy central place in the evaluation of the legal options available to Muslim women upon divorce.

Unwanted Sandra M. Bucerius.2014-08-20 The immigration of Muslims to Europe and the integration of later generations presents many challenges to European societies. *Unwanted* builds on five years of ethnographic research with a group of fifty-five second-generation Muslim immigrant drug dealers in Frankfurt, Germany to examine the relationship between immigration, social exclusion, and the informal economy. Having spent countless hours with these young men, hanging out in the streets, in cafes or bars and at the local community center, Sandra Bucerius explores the intimate aspects of one of the most discriminated and excluded populations in Germany. Bucerius looks at how the young men negotiate their participation in the drug market while still trying to adhere to their cultural and religious obligations and how they struggle to find a place within German society. The young men considered their involvement in the drug trade a response to their exclusion at the same time that it provides a means of forging an identity and a place within German society. The insights into the lives, hopes, and dreams of these young men, who serve as an example for many Muslim and otherwise marginalized immigrant youth groups in Western countries, provides the context necessary to understand their actions while never obscuring the many contradictory facets of their lives.
