Keeping the Peace in the Village describes the nature of conflicts among rural people in the period after the Thirty Years' War. These included property disputes, conflicts between employers and their workers, disputes over marriage promises, and, most often, honor disputes.

Frühneuzeitliche Friedensstiftung in landesgeschichtlicher Perspektive Michael Rohrschneider.2019-11-11 Die Historische Friedensforschung ist angesichts der vielgestaltigen Konflikte der gegenwärtigen Staatenwelt gefragter denn je. Gerade die Epoche der Frühen Neuzeit bietet aufgrund ihrer auffällig hohen Kriegsdichte zahlreiche Anknüpfungspunkte zur Erforschung der Frage, wie in der Vergangenheit konkret versucht wurde, Frieden herzustellen. Zwar sind zentrale Aspekte frühneuzeitlicher Friedensstiftung, wie Friedenskongresse und -verträge, Verhandlungstechniken oder Friedensdenken, in der neueren Geschichtswissenschaft bereits intensiv analysiert worden. In zweiter Reihe stand bislang allerdings die landesgeschichtliche Verortung der erzielten Befunde. Angesichts des defizitären Forschungsstands zielt der Sammelband darauf ab, in territorial und europäisch übergreifender Weise die Potenziale einer Verbindung landesgeschichtlicher Fragestellungen mit der Historischen Friedensforschung aufzuzeigen.

Policey und Strafjustiz in Kurmainz Karl Härter.2005 Die als territoriale Fallstudie angelegte Arbeit behandelt Ordnungsgesetzgebung, Normdurchsetzung und Strafpraxis im frühneuzeitlichen Kurmainz, einem mittleren geistlichen Territorium des Alten Reiches. Sie ist damit im Schnittfeld der

aktuellen (rechts-)historischen Forschungsfelder gute Ordnung und Policey und historische Kriminalitätsforschung situiert. Im Mittelpunkt steht das komplexe Verhältnis zwischen guter Policey und Straffjustiz, das erstmals umfassend und unter Anwendung quantitativer Methoden untersucht wird. Herausgearbeitet wird nicht nur der Prozess der Normgebung, die Expansion der Regelungsmaterien im Bereich des devianten Verhaltens und die Entfaltung eines criminalpoliceylichen Ordnungs- und Sicherheitsdiskurses, sondern auch die praktische Umsetzung und Wirkung der Policey- und Strafnormen. Behandelt werden die Strukturen und die Entwicklung der Strafgerichtsbarkeit, das Straf- und Entscheidungsverfahren, die Schaffung exekutiver Verwaltungs- und Polizeiorgane sowie die Etablierung moderner Techniken der Sozialkontrolle. Ein zweiter Schwerpunkt thematisiert Struktur und Entwicklung der Kriminalität, die Entscheidungspraxis, die Strafzwecke, die Sanktionen und den konkreten Strafvollzug. Praxis und Zusammenwirken von Policeygesetzgebung, Normdurchsetzung, Devianz und Strafe werden schliesslich für drei zentrale Bereiche - Festkultur/Gewalt, Ehe und Sexualität, mobile Randgruppen/Eigentumsdelinquenz - exemplarisch analysiert und dabei auch die Wechselwirkungen und Kommunikationen zwischen Obrigkeit und sozialer Gemeinschaft einbezogen. Im Ergebnis zeigt die Arbeit, dass die für Kurmainz beobachtete Interaktion zwischen guter Policey und Straffjustiz exemplarischen Charakter für die Entwicklung des frühmodernen Staates in Europa besitzt.

Verhör, Vernehmung, Befragung Antje Schumann. 2016-10-13
Was ist eine Vernehmung? Die Regeln der Strafprozessordnung über die Vernehmung sehen zwar sowohl für die vernehmende Person als auch für die vernommene Person bestimmte Rechte und Pflichten vor. Wann jedoch eine Befragung eine Vernehmung ist, dies beantwortet das Gesetz nicht - und das hat Folgen. Denn welche Regeln gelten, wenn der Staat den Bürger nicht förmlich

Leibniz in Mainz Irene Dingel, Michael Kempe, Wenchao Li. 2019-10-07 Die Jahre 1668–1672 in Mainz, im Dienst des Mainzer Erzbischofs Johann Philipp von Schönborn, markieren die erste längere Station im Leben des in Leipzig geborenen Universalgelehrten Gottfried Wilhelm Leibniz (1646–1716) nach dem Abschluss seiner universitären Studien mit der juristischen Promotion im Alter von gerade 20 Jahren. Griese.2014-03-31 The Arab spring, protest movements in the EU, Russia, Turkey or elsewhere, are often labeled as twitter-revolutions. A crucial role is attributed to the new media, coverage of events abroad and ensuing mutual reactions. With the dissemination of print, revolts in early-modern times faced the challenge of a similar media-revolution. This influenced the very face of the events that could become full-fledged propaganda wars once the insurgents had won access to the printing press. But it also had an impact on revolt-narratives. Governments severely persecuted dissident views in such delicate issues as revolts. Observers abroad had no such divided loyalties and were freer to reflect upon the events. Therefore, the book focuses mainly on representations of revolts across borders.
