It is sort of a Wikipedia that will at least provide you with references related to the book you are looking for like, where you can get the book online or offline, even if it doesn't store itself. Therefore, if you know a book that's not listed you can simply add the information on the site. You'll be able to download the books at Project Gutenberg as MOBI, EPUB, or PDF files for your Kindle. The store is easily accessible via any web browser or Android device, but you'll need to create a Google Play account and register a credit card before you can download anything. Your card won't be charged, but you might find it off-putting.
