By December 2009 taxpayers had contributed £338 million, alongside £438 million from private investors. The Department's intervention in the venture capital market was experimental and risky, yet it did not set clear, prioritised objectives for the funds, including the expected economic benefits, and did not set targets at the outset for expected rates of return. The Department did not begin to properly evaluate the progress of its early funds until late 2008 and, to the concern of the Committee, did not publish any information on the funds until December 2009. The evidence suggests that the funds are underperforming. As at December 2008 the Regional Venture Capital Funds, the largest category of early funds, showed negative returns and the average rate of return was minus 15.7 per cent whilst private European venture capital funds of a similar size had an average rate of return of minus 0.4 per cent. The Department has not done enough to curtail the high costs of managing the funds. Fees for the Regional Venture Capital Funds have totalled £46 million compared to the £130 million invested. Substantial fees have been paid to fund managers even though the performance of the funds has been poor.

To emphasize the importance of effective investment governance and to demonstrate its flexibility across organization type, we consider our investment governance process within three contexts: defined contribution (DC) plans, defined benefit (DB) plans, and endowments and foundations (E&Fs). Since the financial crisis of 2007–2008, the financial sector’s place in the economy and its methods and ethics have (rightly, in many cases) been under scrutiny. Coupled with this theme, the task of investment governance is of increasing importance due to the sheer weight of money, the retirement savings gap, demographic trends, regulation and activism, and rising standards of behavior based on higher expectations from those fiduciaries serve. These trends are at the same time related and self-reinforcing. Having explored the why of investment governance, we dedicate the remainder of the book to the question of how to bring it to bear as an essential component of good fiduciary practice. At this point, the reader might expect investment professionals to launch into a discussion about an investment process focused on the best way to capture returns. We resist this temptation.
