In general, given more effective search procedures, there are more potential local associates for joint ventures in less-developed countries than the literature suggests. Most significantly, host government partners are rarely a hindrance and often the most compatible associates for a foreign investor. It appears that the decision to go into a joint venture, the selection of partners and the manner in which it is set up are only partially determined, if at all, by considerations of bilateral monopolistic advantage. Initiation, promotion and development of new ventures tends to be the responsibility of individuals or special interest groups. Hitherto, the area of joint operations in international business has only been examined descriptively. Here is a study which analyzes the subject rigorously and in depth, providing detailed information of the results of a type of operation which is likely to become increasingly significant.
