After Civil War Bill Kissane.2014-10-15 Civil war inevitably causes shifts in state boundaries, demographics, systems of rule, and the bases of legitimate authority—many of the markers of national identity. Yet a shared sense of nationhood is as important to political reconciliation as the reconstruction of state institutions and economic security. After Civil War compares reconstruction projects in Bosnia, Cyprus, Finland, Greece, Kosovo, Northern Ireland, the Republic of Ireland, Spain, and Turkey in order to explore how former combatants and their supporters learn to coexist as one nation in the aftermath of ethnopolitical or ideological violence. After Civil War synthesizes research on civil wars, reconstruction, and nationalism to show how national identity is reconstructed over time in different cultural and socioeconomic contexts, in strong nation-states as well as those with a high level of international intervention. It covers several strands of analysis, including the tension between state sovereignty and humanitarian concerns, and the role of the threat or use of force in coercive international diplomacy.

Familienleben transnational Eveline Ammann Dula.2019-06-30 Wie organisieren transnationale Familien ihre multi-lokalen Lebenswelten? Welche Bedeutung kommt innerfamiliären Hierarchien zu? Welche sozialwissenschaftlichen Methodologien sind geeignet, um das transnationale Familienleben im gesellschaftlichen Kontext zu erforschen? Austrian Foreign Policy in Historical Context Anton Pelinka,Gunter Bischof,Michael Gehler.2017-11-30 In 2005, Austria celebrated the sixtieth anniversary of its liberation from the Nazi regime and the fiftieth anniversary of the State Treaty that ended the occupation and returned full sovereignty to the country. This volume of Contemporary Austrian Studies covers foreign policy in the twentieth century. It offers an up-to-date status report of Austria's foreign policy trajectories and diplomatic options. Eva Nowotny, the current Austrian ambassador to the United States, introduces the volume with an analysis of the art and practice of Austrian diplomacy in historical perspective. Ambassador Wolfgang Petritsch analyzes recent Balkans diplomacy as an EU emissary in the Bosnian and Kosovo crises. Historians Gunter Kronenbitter, Alexander Lassner, Gunter Bischof, Joanna Granville, and Martin Kofler provide historical case studies of pre-and post-World War I and World War II Austrian diplomacy, Austria's dealings with the Hungarian crisis of 1956, and its mediation between Kennedy and Khrushchev in the early 1960s. Political scientists Romain Kirt, Stefan Mayer, and Gunter Hauser analyze small states' foreign policymaking in a globalizing world, Austrian federal states' separate regional policy initiatives abroad and Austria's role vis-à-vis current European security initiatives. Michael Gehler periodizes post-World War II Austrian foreign policy regimes and provides a valuable summary of both the available archival and printed diplomatic source collections. A Historiography Roundtable is dedicated to the Austrian Occupation decade. Gunter Bischof reports on the state of occupation historiography; Oliver Rathkolb on the historical memory of the occupation; Michael Gehler on the context of the German question; and Wolfgang Mueller and Norman Naimark on Stalin's Cold War and Soviet policies towards Austria during those years. Review essays and book reviews on art theft, anti-Semitism, the Hungarian crisis of 1956, among other topics, complete the volume.

Kosovo, A Documentary History Robert Elsie,Bejtullah D. Destani.2018-01-30 The question of Kosovan sovereignty and independence has a history which stretches far back beyond the outbreak of war in 1998. This volume is a compilation of key documents on Kosovo from the first half of the twentieth century. These texts, including numerous diplomatic despatches from the British Foreign Office, deal initially with the Albanian uprising against Ottoman rule in the spring of 1912 and, in particular, with the period of the Serbian invasion of Kosovo in late 1912 and the repercussions of the conquest for the Albanian population. The documents from 1918 to the early 1920s focus mainly on endeavours by Albanian leaders, including those of the so-called Kosovo Committee in exile, to bring the plight of their people to the attention of the outside world - endeavours which largely failed. Further documents reflect the situation in Kosovo up to the outbreak of World War II. This collection provides new perspectives on the Kosovo question and includes many documents which have been largely unavailable up to now. It sheds new light on many of the major and minor episodes that channelled and determined subsequent events, including the Kosovo War of 1998-1999 and the declaration of independence in February 2008.

The War in Our Backyard Margit V. Wunsch Gaarmann.2015-02-18 The War in Our Backyard is a novel study of the German press' textual and visual coverage of the wars in Bosnia (1992-1995) and Kosovo (1998-1999). Key moments from both wars have been selected and analysed using a broad range of publications reaching from far-right to far-left and including broadsheets, a tabloid and a news magazine. Two sections with parallel chapters form the core of the book: the first part dealing with the war in Bosnia and the second with Kosovo. Each section contains one chapter on the initial phase of the conflict, one chapter on an important atrocity - namely the Srebrenica Massacre in Bosnia and the Račak incident in Kosovo - and, lastly, a chapter each on the international involvement which ended the immediate violence. The book examines how the various events were covered, what sources were used and what insights these examples of the German press conveyed. Special attention has been paid to four key themes, which emerged from the research.

Firstly, the changing perceptions of the Serbian President Slobodan Milošević and the issue of who was to blame for the conflicts; secondly, how various armed forces, including the Yugoslav Peoples' Army and the Kosovo Liberation Army were presented in the German press; thirdly, the persistent presence of the Second World War and the Holocaust in the coverage of the wars in Bosnia and Kosovo and how they shaped the press' interpretation of the violence; and lastly, how Germany's role in the Balkans – both in the realms of diplomacy and military intervention – was evaluated by the national press. Pictures and cartoons accompanying the textual coverage have been included to present a more rounded picture of press coverage.

Nation Failure, Ethnic Elites, and Balance of Power Shinasi A. Rama.2019-01-12 This book examines the history of nation-building in Kosovo as a model of how the theories behind nation-building, state-building and peace-building can succeed or fail. The author argues that two missing factors led to successful state-building but failed nation-building in Kosovo: the balance of power and the ethnic elite. The author uses his unique expert knowledge gained over thirty years of study to present a thorough overview of international administration and nation-building in Kosovo.

Unauthorised Humanitarian Interventions in World Politics Christian Pohlmann.2020-12-02 The question if states should intervene in massive humanitarian emergencies without a legal right to do so, is still object of an important debate in the theory and practice of international relations. This situation has not changed with the emergence of the 'Responsibility to Protect' norm, which stopped short of a right to intervene without a Security Council authorisation. The book assesses the impact of such unauthorised humanitarian interventions on international society and regions; it is written in the context of the English School of International Relations. Based on empirical studies the author argues that they can be progressive-constructive for international order, if conducted with explicit legitimacy, integrity, and great power participation. The argument is based on the analysis of six cases conducted between 1946 and 2005. Specific consideration is given to the cases of Liberia (1990) and Kosovo (1999). In sum, the book contributes to the solidarism-pluralism debate and the discourse on humanitarian interventions.

Reassuring the Reluctant Warriors Stefano Recchia.2015-09-04 Why did American leaders work hard to secure multilateral approval from the United Nations or NATO for military interventions in Haiti, the Balkans, and Libya, while making only limited efforts to gain such approval for the 2003 Iraq War? In *Reassuring the Reluctant Warriors*, Stefano Recchia addresses this important question by drawing on declassified documents and about one hundred interviews with civilian and military leaders. The most assertive, hawkish, and influential civilian leaders, he argues, tend to downplay the costs of intervention, and when confronted with hesitant international partners they often want to bypass multilateral bodies. America's top-level generals, by contrast, are usually reluctant warriors who worry that intervention will result in open-ended stabilization missions; consequently, the military craves international burden sharing and values the potential exit ramp for U.S. forces that a handoff to the UN or NATO can provide. Recchia demonstrates that when the military speaks up and clearly expresses its concerns, even strongly pro-intervention civilian leaders can be expected to work hard to secure UN or NATO approval—if only to reassure the military about the likelihood of sustained burden sharing. Conversely, when the military stays silent, as it did in the run-up to the 2003 Iraq War, bellicose civilian leaders are empowered; the United States is then more likely to bypass multilateral bodies, and it may end up carrying a heavy stabilization burden largely by itself. Recchia's argument that the military has the ability to contribute not only to a more prudent but also to a more multilateralist U.S. intervention policy may be counterintuitive, but the evidence is compelling.

Peace Lost: The Failure of Conflict Prevention in Kosovo Marc Weller.2009-01-09 This book traces the failure of international action in Kosovo from the late 1980s until NATO intervention in 1999, and endeavours to explain why, during that time, so many opportunities for making peace were squandered. Applying methodology developed by the EU Conflict Prevention Network, it divides the conflict into four main phases and examines how, at each, chances for settlement were either lost or overlooked. It considers policy alternatives available at the time, and hypothesises reasons why these were ultimately discarded. Drawing on a wide range of sources, including the author's own experience of the negotiations process, this book presents a hitherto unexplored thesis of the Kosovo conflict, that of a 'lag' in international action in relation to the situation on the ground, and seeks to draw from these failures some central lessons for the future of conflict prevention.

Hegemoniebildung und Elitentransformation im Kosovo. Von der spätosmanischen Herrschaft bis zur Republik Raoul Ott.2023-10-17 Der Kosovo-Konflikt aus den 1990er Jahren wirft seine Schatten bis in die Gegenwart auf den südosteuropäischen Raum. Seine Ursachen und Nachwirkungen scheinen dabei durch eine simplifizierte Dichotomie anhand ethnischer Grenzen festgeschrieben. Dass eine derartige Sichtweise jedoch nicht nur vermeintliche politisch-ethnische Gegensätze unhinterfragt fortschreibt, sondern gleichfalls Herrschaftsbeziehungen außer Acht lässt, ist so naheliegend wie unbefriedigend. This book is an excellent access point for students, researchers, and anyone wanting to know more about Kosovo.

Islamist Extremism in Kosovo and the Countries of the Region Kolë Krasniqi.2019-09-09 This brief analyzes the social, historical and societal circumstances influencing the emergence of Islamist extremism in Kosovo and countries of the region. It discusses the creation of propagandist infrastructure by foreign organizations to spread radical ideology and instigate inter-religious conflicts in order to establish an Islamist extremist movement, and highlights the camouflaged activities of humanitarian organizations funding terrorism. This brief focuses particularly on examining the development and concrete manifestation of Islamism and the latent risks posed by Islamist extremism not just for the national security of Kosovo but also for the peace and safety of the entire region. Examining the development, effects and latent risks posed by Islamist extremism in the Balkans, *Islamist Extremism in Kosovo and the Countries of the Region* will be useful to scholars, policy-makers, and law enforcement practitioners working in counter-terrorism, as well as those interested in the unique sociopolitical climate of the Balkans.

Organizing Peacebuilding Anna Herrhausen.2009 Coordination between different United Nations (UN) entities has become an issue of increasing concern for scholars and practitioners. With the UN taking on ever more ambitious roles in countries emerging from conflict, no single unit can master the task of post-conflict reconstruction alone. However, efforts at reorganizing the way the UN works in peacebuilding have not yielded the desired result of ensuring a more effective UN presence. To offer fresh inputs for the debate, *Organizing Peacebuilding* looks at coordination from a theoretical perspective. It develops a framework for interorganizational coordination and applies it to the UN and to two selected case examples, the UN missions in Kosovo and Afghanistan. The research suggests that in order to improve coordination, the UN should acknowledge its network character and cultivate those social and structural control mechanisms which facilitate coordination in networks.

Social Inequalities and Discontent in Yugoslav Socialism Rory Archer, Igor Duda, Paul Stubbs.2016-03-31 Socialist countries like Yugoslavia garnered legitimacy through appealing to social equality. Yet social stratification was characteristic of Yugoslav society and increased over the course of the state's existence. By the 1980s the country was divided on socio-economic as well as national lines. Through case studies from a range of social milieux, contributors to this volume seek to 'bring class back in' to Yugoslav historiography, exploring how theorisations of social class informed the politics and policies of social mobility and conversely, how societal or grassroots understandings of class have influenced politics and policy. Rather than focusing on regional differentiation between Yugoslav republics and provinces the emphasis is placed on social differentiation and discontent within particular communities. The contributing authors of these historical studies come from diverse disciplinary backgrounds, linking scholarship from the socialist era to contemporary research based on accessing newly available primary sources. Voices of a wide spectrum of informants are included in the volume; from factory workers and subsistence farmers to fictional television characters and pop-folk music superstars.

Civic and Uncivic Values in Kosovo Sabrina P. Ramet, Albert Simkus, Ola Listhaug.2015-02-01 This volume is driven by the conviction that the key to the establishment of stable liberal democracy anywhere in the world and, in this case, in Kosovo lies in the completion of three interrelated tasks: first, the creation of effective political institutions, based on the principle of the separation of powers (including the independence of the judiciary); second, the promotion of the rule of law; and, third, the promotion of civic values, including tolerance or ethnic/religious/sexual minorities, trust, and respect for the harm principle. In fact, there are problems across all three measures, including with judicial independence, with the rule of law, and with civic values. On the last of these, research findings show that the citizens of Kosovo rank extremely low on trust of other citizens, low on engagement in social organizations, and tolerance of gays, lesbians, and atheists, but high on trust in the political institutions of their country and in pride of their newly independent state.
