*Afrotopia* Felwine Sarr.2020-03-17 A vibrant meditation and poetic call for an African utopian philosophy of self-reinvention for the twenty-first century In the recent aftermath of colonialism, civil wars, and the AIDS crisis, a new day finally seems to be shining on the African continent. Africa has once again become a site of creative potential and a vibrant center of economic growth and production. No longer stigmatized by stereotypes or encumbered by the traumas of the past—yet unsure of the future—Africa has other options than simply to follow paths already carved out by the global economy. Instead, the philosopher Felwine Sarr urges the continent to set out on its own renewal and self-discovery—an active utopia that requires a deep historical reflection on the continent’s vast mythological universe and ancient traditions, nourishes a cultural reinvention, and embraces green technologies for tackling climate change and demographic challenges. Through a reflection on contemporary African writers, artists, intellectuals, and musicians, Sarr elaborates Africa’s unique philosophies and notions of communal value and economy deeply rooted in its ancient traditions and landscape—concepts such as ubuntu, the life force in Dogon culture; the Rwandan imihigo; and the Senegalese teranga. Sarr takes the reader on a philosophical journey that is as much inward as outward, demanding an elevation of the collective consciousness. Along the way, one sees the contours of an africanity, a contemporary Africa united as a continent through the creolization of its cultural traditions. This is Felwine Sarr’s *Afrotopia*.

**Cipango** Tomás Harris.2010 Chilean poet Tomas Harris's

Cipango - written in the 1980s, first published in 1992, and considered by many to be the author's best work to date - employs the metaphor of a journey. The poems collectively allude to the voyage of Columbus, who believed that he'd reached the Far East (Cipango, or Japan), not the Americas. Building on that mistaken historical premise, Cipango comments on the oppressive legacy of colonialism in Latin America - manifested in twentieth-century Chile through the 1973 military coup by Augusto Pinochet and the brutal dictatorship there - and on the violence and degradation of contemporary urban society. The author's vision is of a decadent, apocalyptic world that nonetheless contains the possibility for regeneration. Cipango is characterized by strange and obsessive imagery-strips of mud, will-o'-the-wisps, vacant lots, blue rats - juxtapositions of contemporary and archaic diction and of incongruous settings that range over time and place; the use of an understated irony; and a dark, incantatory voice. The speakers in various poems address personages such as Columbus, Marco Polo, and the Great Khan, and refer to a breadth of sources including Columbus's diaries, Genet's *Our Lady of the Flowers*, Bram Stoker's *Dracula*, Nerval's *Aurelia*, the Holocaust, Billie Holiday, and the film *Goldfinger*. The book's content and formal elements combine to produce a work of almost epic scope, one with universal appeal. Tomas Harris's oeuvre, and in particular, *Cipango*, grows out of the Chilean poetic tradition - one that has produced such greats as Vicente Huibobro, Gabriela Mistral, Pablo Neruda, and Nicanor Parra, all of whose poetry has been published to greater or lesser degree in translation in the United States. Harris's poetry, on the other hand, while celebrated in his native Chile and throughout Latin America, has been underrecognized in this country. This bilingual, en-face edition of *Cipango*, deftly translated by Daniel Shapiro, remedies that situation by bringing the lyricism and power of one of Chile's, and Latin America's, major poetic voices to a U.S. English-language readership. The copious end-notes following the poetry

in the edition explain the book's numerous literary, historical, and other references. Given Cipango's outstanding literary merit as well as the timeliness of its themes and the specific tradition it belongs to, it will be a valuable resource and source of pleasure for instructors and students of Latin American and comparative literatures as well as for poets, translators, and general readers in the United States. --Book Jacket.

*Ethnic Diversity, Plural Democracy and Human Dignity* Mario Krešić, Damir Banović, Alberto Carrio Sampedro, Jānis Pleps. 2022-04-25

“Given their ethnic diversity, to what extent, and at what cost and benefit to human dignity, can European countries adopt and adapt plural democracy?” The contributors to this volume offer answers to this question from a variety of multidisciplinary perspectives within the framework of the integral theory of law and the state. Their shared aim is to explain legal phenomena in the context of other relevant issues and to identify, analyse and critique conceptualizations, problems and situations. This volume is rooted in the historical and contemporary European experience with special cases from Bosnia and Hercegovina, Croatia, Latvia, Slovenia, Spain and Canada which are relevant for understanding the European problem. Solutions to the problem are sought through innovative interpretations of the rule of law, democracy and human dignity, which are followed by argumentation about how these concepts, when recognized as European legal principles, can be implemented in order to avoid ethnic conflicts. Following an introduction that defines the problem at the centre of the book and explains how legal theory can be used to address it, the book consists of eleven contributions divided into three thematic sections. The first covers topics concerning the European principles which can help avoid ethnic conflicts: the principle of compulsory adjudication in interstate relations, the principle of democracy, and principles regarding the recognition of individual and collective identities. These European principles are then

investigated by drawing on legal and political theories. The second section presents three ways of conceptualizing ethnical needs in multi-ethnic states: asymmetric federalism, dêmoicratic account and cooperative federalism. The third and final section elaborates on issues concerning the protection of minority rights: the role of judicial ideology in protecting minority rights, citizenship, the EU mechanism for the protection of minority rights, and the importance of remembering tragic events affecting minorities.

**Republicanism and the Future of Democracy** Geneviève Rousselière, Yiftah Elazar. 2019-04-25 Explores how republican political thought can make a constructive and distinctive contribution to our understanding of democracy and the challenges it faces.

**Peru** John Crabtree, Francisco Durand. 2017-05-15 While leftist governments have been elected across Latin America, this 'Pink Tide' has so far failed to reach Peru. Instead, the corporate elite remains firmly entrenched, and the left continues to be marginalised. Peru therefore represents a particularly stark example of 'state capture', in which an extreme concentration of wealth in the hands of a few corporations and pro-market technocrats has resulted in a monopoly on political power. Post the 2016 elections, John Crabtree and Francisco Durand look at the ways in which these elites have been able to consolidate their position at the expense of genuine democracy, with a particular focus on the role of mining and other extractive industries, where extensive privatization and deregulation has contributed to extreme disparities in wealth and power. In the process, Crabtree and Durand provide a unique case study of state development, by revealing the mechanisms used by elites to dominate political discussion and marginalize their opponents, as well as the role played by external actors such as international financial institutions and foreign investors. The significance of Crabtree's findings therefore extends far beyond Peru, and illuminates the

wider issue of why mineral-rich countries so often struggle to attain meaningful democracy.

**The Power to Dismiss** Patrick Emmenegger.2014-10-16 This first comparative-historical analysis of the regulations that restrict the managerial capacity to dismiss employees and use temporary forms of employment addresses four puzzles that have long troubled the comparative political economy literature. Who is the driving force behind the extension of dismissal protection? Why is statutory dismissal protection particularly extensive in continental Europe? How can the uneven temporal development of job security regulations be explained? And what are the causes of the two-tier labour market reforms in recent decades?

Analysing the historical development of job security regulations in Western Europe from the establishment of freedom of contract in the 19th century until the peak of two-tier labour market reforms in the 2000s, this book contributes to resolving these puzzles by emphasising the important role of trade unions, their preference for institutional control, and the strategic choices they make.

Rethinking Anarchy Carlos Taibo.2018-12-18 This is the first book by Carlos Taibo, a prolific and well-known social theorist in Spain, to be translated into English. Published in it's original language in 2013, Rethinking Anarchy functions as both an introduction to and in-depth interrogation of anarchism as political philosophy and political strategy. Taibo introduces the basic tenets of anarchism while also diving into and unpacking the debates around each of them, producing a book that should appeal to both beginners and readers with extensive knowledge of the book's theme. Topics touched upon include liberal versus direct democracy, the nature of the state and its relationship to capitalism, the role of autonomous and anticapitalist social spaces, and how anarchism relates to feminism, environmentalism, antimilitarism, and other struggles.

**A General Theory of Domination and Justice** Frank Lovett.2010-05-13 In all societies, past and present, many persons

and groups have been subject to domination. Properly understood, domination is a great evil, the suffering of which ought to be minimized so far as possible. Surprisingly, however, political and social theorists have failed to provide a detailed analysis of the concept of domination in general. This study aims to redress this lacuna. It argues first, that domination should be understood as a condition experienced by persons or groups to the extent that they are dependent on a social relationship in which some other person or group wields arbitrary power over them; this is termed the 'arbitrary power conception' of domination. It argues second, that we should regard it as wrong to perpetrate or permit unnecessary domination and, thus, that as a matter of justice the political and social institutions and practices of any society should be organized so as to minimize avoidable domination; this is termed 'justice as minimizing domination', a conception of social justice that connects with more familiar civic republican accounts of freedom as non-domination. In developing these arguments, this study employs a variety of methodological techniques - including conceptual analysis, formal modelling, social theory, and moral philosophy; existing accounts of dependency, power, social convention, and so on are clarified, expanded, or revised along the way. While of special interest to contemporary civic republicans, this study should appeal to a broad audience with diverse methodological and substantive interests.

Democracy is path and an endless goal, unless democracy itself.

Democratic Practice Robert M. Fishman.2019-03-04 At a time of growing concern over the fate of contemporary democracy this book shows how vast differences between countries in forms of political conduct, and taken for granted assumptions, determine what democracies actually accomplish. In *Democratic Practice*, Robert M. Fishman elucidates why some democracies include the economically underprivileged, and cultural others within the circles of political relevance that set policies and the political agenda, whereas others exclude them. On the basis of in-depth research on Portugal and Spain, Fishman develops a theoretically innovative explanation for the breadth of democratic inclusion and draws out large implications for democracies everywhere. *Democratic Practice* examines the record of two countries that began the worldwide turn to democracy in the 1970s, showing how and why basic assumptions about what democracy is, and how political actors should treat one another, diverged. The book offers detailed empirical evidence on how an inclusive approach to democratic politics provides major benefits not only for the poor and excluded but also for others, drawing large lessons for contemporary democracies.



Catalan Independence and the Crisis of Sovereignty Óscar García Agustín. 2020-12-14 This book explores the conflict between the Catalan project to become independent and the Spanish state's opposition to any attempt of secessionism. The volume addresses some of the key political and academic issues of contemporary European societies: nationalism, separatism and sovereignty. The banned referendum in Catalonia in October 2017 unveiled the existence of multiple crises, from territorial to economic and political. Indeed, the Catalan issue is about the crisis of sovereignty: who holds legitimacy to make decisions, and who is in power legally and politically? The book is structured according to three themes: sovereignty and its people, where the realignment to independence, populism and the definition of the demos are discussed; collective identities and actions, to account for the shaping of 'us', the importance of collective memory and the cross-alliances forged during the referendum; and internationalization, focusing on Europeanisation, international media and comparative constitutional perspectives.

More specifically, those issues concern the interplay between notions of democracy (and democratic ends and means) and law (and the rule of law and constitutionalism). Against this background, the editors use amorality in order to escape the terrain of the justification of secession by making a distinction between the democratic theory of secession and the theory of democratic secession. In the first section, the theoretical nexus democracy-secession has been approached both from a legal and political theory perspective. The second section of the book examines the instruments that the theory of democratic secession invokes in order to justify secession and presents both legal and political science contributions. The third section focuses on social movements and political actors. The fourth section focuses on two case studies due to the awareness of the importance of the difference between secession in a democratic occidental context (which call into play the discussion of the democratic theories) and separations in a non-democratic context (where the nexus between secession and democracy is

not really central).

**Odebrecht, la empresa que capturaba gobiernos** Francisco

Durand.2018-11-04 ¿Es el Estado quien se colude o corrompe a las empresas, o son las empresas las que toman la iniciativa? Se suele dar por hecho que la corrupción proviene del Estado y que las empresas, para poder competir, necesitan ceder a las presiones de políticos y funcionarios. Sin embargo, a partir del concepto de captura del Estado, este libro nos plantea que existe un acuerdo establecido entre ambos actores, y que muchas veces es la empresa la que toma la iniciativa y diseña toda una serie de mecanismos de influencia. La colusión y la corrupción en obras públicas involucra también a otras empresas, formando carteles, o seduciendo a árbitros privados para ganar arbitrajes en

disputas con el Estado. Estamos entonces frente a un problema tan grave como complejo. No se trata solo o principalmente de escándalos, o presupuestos inflados artificialmente, sino de todo un sistema que pocos conocen. Es hora de explicarlo. Odebrecht, la empresa que capturaba gobiernos nos muestra estos arreglos entre las corporaciones con la élite del Estado, analizando en gran detalle tres casos emblemáticos: el Metro de Lima, la carretera Interocéánica Sur y el proyecto de irrigación de Olmos, todos realizados con la intervención de la empresa brasileña.
